# Declaration of Conformity REACH

Coster Group Srl certifies that its products fully comply with the requirements of the European Union Regulation (EC) 1907/2006 on the registration, evaluation, authorization and restriction of chemicals (REACH):

1. According to the structure of the REACH regulation, Coster Group is a manufacturer of "ITEMS" for its customers. It does not produce "substances" or "preparations" and its articles do not involve the intentional release of substances. Registration or pre-registration or authorization is not required for the items provided.
2. Concerning the requirements of Article 33 of REACH: " Duty to communicate information on substances in articles", Coster Group declares that none of the SVHCs (Candidate List of Substances of Very High Concern for Authorisation published in accordance with Article 59 of the REACH Regulation) is present in its articles in a concentration equal to or greater than 0.1%
3. Concerning the requirements of Article 67 of REACH: " A substance on its own, in a mixture or in an article, for which Annex XVII contains a restriction shall not be manufactured, placed on the market or used unless it complies with the conditions of that restriction", Coster Group declares that none of the substances subject to restriction of use is present in its products.


